



## **City of Liberty Hill Owner Release and Waiver of Liability**

I hereby release and agree to not hold liable the City of Liberty Hill (“CITY”), its officers, agents, volunteers, and employees or the Liberty Hill Community Resource Center (“CRC”), its officers, agents, volunteers, and employees from any and all claims of any kind arising from this City Cleanup Project (“Project”) and due to the ordinary negligence of the City. I further agree to the following:

1. I understand that the CITY may, at any time, for whatever reason, make changes to the Project or terminate my participation in the Project with the CITY. I understand that I may decide to sever my participation in the Project with the CITY at any time. Notice of termination of participation in the Project must be communicated in writing as soon as possible to the Project Coordinator.
2. I understand and agree as an Owner that this Release discharges the City of Liberty Hill and CRC from any liability or claim that I may have against the City of Liberty Hill or CRC with respect to any bodily injury, personal injury, illness, death, or property damage that may result from my activities with the CITY, whether caused by negligence of the CITY, the CRC or their officers, directors, employees, volunteers, or agents, or otherwise.
3. I understand that the CITY does not assume any responsibility for and has no obligation to provide financial or other assistance, including but not limited to medical, health or disability insurance, in the event of injury or illness.
4. I and my personal representatives, heirs and assigns, voluntarily waive, release, discharge, hold harmless, defend, and indemnify the CITY and, their volunteers, employees, agents, and officers from any and all claims, actions, losses for bodily injury, property damage, wrongful death, loss of services, or otherwise, which may arise in any manner from my participation in the Project.
5. I understand and agree to abide by all policies and procedures of the CITY and CRC and the assigned department(s) relating to the performance of duties and responsibilities required of me.
6. I understand and agree that, in the course of my participation as an Owner, I may have to provide access to information or security related items (i.e., keys, combinations, access to private property, etc.) that are confidential. I understand and acknowledge that I will provide access to this information or any other security-related information to the appropriate persons as approved by the Project Coordinator. I understand that my participation in the Project may be terminated if I fail to make proper disclosure of this or any other necessary information.
7. I grant the CITY, its successors, assigns, and licensees, the perpetual right to photograph, film, use and reproduce, as the CITY desires, photographs and videotapes taken of me and/or my children during the Project. I understand that I will not receive any compensation for my participation or my children's participation in the photographs and videotapes and that the CITY shall own all right, title, and interest to the photographs and videotapes, including the portions that contain the images and voices of me and/or my children.
